Forms of Violence

What is Relationship Violence?

Relationship violence, also known as domestic violence or spousal abuse, is when someone in an intimate relationship uses power and control over their partner using methods involving physical, sexual, mental, emotional, and/or economic abuse.

What is Sexual Violence?

Sexual violence is conduct of a sexual or indecent nature toward another person and is accompanied by actual or threatened physical force that induces fear, shame, or mental suffering. Sexual violence is usually sexual contact forced upon a person without consent or inflicted upon a person unable to give consent (because they are too young or are physically or mentally incapacitated).

We offer assistance regardless of whether you choose to report to law enforcement, are unsure about reporting, or have reported and the case is under investigation.

Civil Advocacy

Civil Advocates provide:

- Crisis Counseling
- Emotional Support
- Danger Assessment
- Referrals to community resources
- Assistance with a Temporary Order of Protection (TOP)
- Preparation for, and support at, your TOP hearing

Temporary Orders of Protection

You might qualify for a TOP if:

- You are in fear of immediate danger
- Have reasonable fear of bodily injury
- Have experienced one or more:
 - Partner or Family Member Assault
 - Sexual Assault
 - Sexual Intercourse without Consent
 - Incest
 - Stalking
 - Assault

Criminal Advocacy

Criminal Advocates provide:

- Emotional support throughout the criminal case
- Information regarding court dates
- Explanation of court hearings
- Referrals to community resources
- Communication with the prosecutor and courts
- Information on victims' legal rights and protections
- Assistance with victim compensation applications
- Support at interviews with prosecutor, defense attorney, or law enforcement
