

## **INTER-AGENCY COLLABORATION BENEFITS ALL**

Missoula County Public Works placed asphalt millings on Deer Creek Road from the shooting range to Crystal Creek Road during night shifts from 5 p.m. to approximately 6 a.m. The work took four days until all material from the Montana Department of Transportation project was delivered for use. Work was completed during night shifts due to contractual requirements between MDT and their contractor in order to reduce impacts to interstate travel during the day. Re-using asphalt products instead of disposal is a great way to make improvements to county-maintained roads and helps reduce dust/maintenance needs on a gravel road with high volumes of recreational traffic. These free, hard-surface millings happened through a cooperative agreement with MDT.

'Public Works is applying for American Rescue Plan Act (ARPA) funding that will provide \$8.5M to make upgrades to the four sewer and water systems.' The landscape in Missoula County is changing from bright greens to various shades of brown as temperatures reach unprecedented highs. It's also about the time we're halfway into mowing season. Last summer was a struggle. It seemed both mowers were in the shop more than they were mowing. Thankfully this season we received a new mower, with another arriving this winter. With three mowers, roadsides should have better vegetation management improving sight distances at intersections, enhanced drainage and reduced fire risks, and reduced spread of noxious weeds.

Public Works is applying for American Rescue Plan Act (ARPA) funding that will provide \$8.5M to make upgrades to the four sewer and water systems - Lolo, Elmar, Sunset West and Lewis and Clark. Improvements include some new water mains and a secondary lift station in parts of the Lolo water system, as well as additional upgrades to the sewer treatment plant. In Elmar, a well pump will be replaced, flooding of the underground pump will be addressed on the Sunset West system, and a new dosing tank will be installed in the Lewis and Clark system. We expect all proposed projects will be selected for the limited ARPA funding as they are all worthy candidates. We are also coordinating with our partners at Community and Planning Services (CAPS) to apply for ARPA funding to assist with the completion of phase 2 of the Buena Vista sewer system.

Even with the pandemic, volatile prices, and material shortages, the Building Division continues to experience a high volume of permit applications, all while in the process of hiring a new Building Official, Permit Specialist, and Inspector. Even with a small staff, the team continues to provide the best customer service possible.



#### **Community Comes Together**

May showers caused serious road and bridge problems in Condon. Downed trees on Glacier Creek Road led to erosion and a washed-out approach at the bridge. The four-person Seeley Lake crew was spread thin while waiting for help from Missoula. removal was coordinated Tree immediately with local contractors so the Road Department was able to stabilize the erosion and reconstruct the washed-out approach. Access for the residents was restored by the end of business hours. Special thanks to residents and contractors that helped with trees, for blocking Glacier Creek Road to prevent drivers from crossing the bridge, as well as finding alternate access thru neighboring properties and Forest Service roads. Local contractors stopped their work and were able and willing to lend a hand to help their neighbors and the Road Department.





#### **Dust Abatement Season Complete**

Dust abatement season started June 21 west of Missoula. The dust abatement winners, as in 2016, was Dust Busters. Due to spring rains and schedule of the independent contractor, dust abatement start dates always pose a challenge. Unfortunately this year, due to the Union Pacific Railroad's closed railway access for train track repairs, the product being used for dust abatement was not available. The. postponement set us back three working days but we were able to start again just in time to stop for the Independence Day weekend. Delays to what is normally a consistent two-week coordinated effort put us at a three-week span.
